Registration Process:

1. Register via the official form on the event website.
2. Each delegate must provide a unique email ID and mobile number.
3. Complete all the fields accurately.
4. Registration is confirmed only upon receipt of full payment, as stated in the payment instructions.
5. A confirmation email will be sent to your registered email address, including a link to book the venue hotel at a special rate for ISC 2027.

Payment:

1. Payments must be made online via the authorised gateway on the event website.
2. Transaction charges, if applicable, will be borne by the registrant.

Terms and Conditions:

1. The registration fee includes access to business sessions and exhibitions, refreshments, delegate kit, entry to conference-related networking functions, lunch on all three conference days, dinner

on two days and coffee/tea during the conference at designated areas, as well as access to cultural events.

2. The registration fee does not include hotel accommodation, airport pick-up/drop-off or local transportation. Delegates are advised to make hotel reservations in advance to avoid last-minute inconvenience.
3. Registration for spouses accompanying delegates is mandatory. Spouse registration is meant solely for the delegate's husband or wife. It does not extend to children, colleagues or other family members. We sincerely appreciate your understanding and kindly note that the Committee will review each application and reserves the right to make the final decision on acceptance.
4. Spouse registration includes access to the Exhibition Hall, Welcome Dinner on 1 March 2027, Gala Dinner on 3 March 2027, Cultural Events and other social functions held during the conference, excluding business sessions.
5. Registration fees once paid to ISC/AISEF are non-refundable under any circumstances.
6. While completing the application form, ensure all details are accurate. Delegate name, Email ID, Company Name and Phone number cannot be changed once registration is submitted.
7. Delegate Badges will be issued at the Registration Counters during the event. All delegates are required to wear their registration badge at all times throughout the conference and exhibition. Access to sessions, lunches, dinners and other activities is controlled via the QR code on the badge.

Cancellation and Refund Policy:

1. Cancellations must be submitted in writing to the email address mentioned on the event website.
2. Registration fees are non-refundable.
