Registration Process:

- 1. If you become an AISEF member and also register for ISC 2026 on or before 28 November, 2025, your annual subscription fee for FY 2025-26, will be waived off. This exclusive offer is available only until 28 November, 2025. Additionally, the International Spice Conference delegate fee will be based on the early bird rates for AISEF members at that time.
- 2. If you are interested to avail this offer, please mail to support@internationalspiceconference.com with all your company details.
- 3. AISEF will send you a form which needs to be duly filled and sent back.
- 4. Eligibility will be verified by the Organizing Committee before confirmation which may take upto 1 week.
- 5. Once your membership is vetted and approved by the organising Committee, payment details will be emailed to you.

- 6. Upon receipt of payment, ISC 2026 registration link will be sent.
- 7. Each delegate must provide a unique email ID and mobile number.
- 8. Complete all the fields accurately.
- 9. A confirmation email will be sent to your registered email address, including a link for booking the venue hotel at a special rate for ISC 2026.
- 10. Confirmation of registration is contingent upon full payment, in accordance with the provided payment instructions.

Payment:

- 1. Payments must be made via the link or the bank details provided.
- 2. Transaction charges, if applicable, will be borne by the registrant.

Terms and Conditions:

- 1. This special combo offer is only valid until 28 November, 2025.
- 2. This offer is only accessible to companies who have not been members of All India Spices Exporters Forum for the past two consecutive years (1st April 2023 to 31st March 2025).
- 3. An application will be considered valid only after the individual has been vetted by the Organizing Committee. Please note that the vetting process may take up to one week.
- 4. Once the Organizing Committee confirms eligibility, a payment link will be sent to the registered email address.
- 5. The registration fee includes access to business sessions and exhibitions, refreshments, a delegate kit, entry to conference-related networking functions, lunch on all three conference days, dinner on two days, coffee/tea served at designated areas during the conference, and access to cultural events.
- 6. The registration fee does not cover hotel accommodation, airport pick-up/drop-off, or local transportation. Delegates are advised to book their hotel accommodations in advance to avoid any last-minute inconvenience.
- Registration for spouses accompanying delegates is mandatory. Spouse registration includes access
 to the Exhibition Hall, the Welcome Dinner on 23 February 2026, the Gala Dinner on 25 February
 2026, access to cultural events, and other social activities during the conference (excluding business
 sessions).
- 8. Registration fees, once paid to ISC/AISEF, are non-refundable under any circumstances.
- 9. When filling out the application form, please ensure that all details—such as the delegate's name, email address, company name, and phone number—are accurate. These details cannot be amended once the registration has been submitted.
- 10. Delegate badges will be issued at the registration counters during the event. All delegates are required to wear their registration badge throughout the conference and exhibition. Access to sessions, lunches, dinners, and other activities will be controlled via the QR code on the badge.

Cancellation and Refund Policy:

- 1. Cancellations must be submitted in writing to the email address mentioned on the event website.
- 2. Registration fees are non-refundable.

Attendee Substitution:

- 1. If you are unable to attend the event, you may request a substitution by notifying us in writing at least 5 days before the event.
- 2. Substitutions can only be made for an individual of the same organization.
