Registration Process:

- 1. Registration for the event can be completed through the online registration form available on our event website.
- 2. Email id and Mobile Number should be unique for each delegate
- 3. Ensure that all the required fields in the registration form are filled in accurately and completely.
- 4. Registration is considered complete only upon receipt of the registration fee as mentioned in the payment instructions.
- 5. Upon successful registration, you will receive a confirmation email to your registered email id with a link to book the venue hotel at a special rate for ISC 2024.

Payment:

- 1. Payments can only be made online through the payment gateway options provided on the event website.
- 2. Please note that online transaction charges, if applicable, will be borne by the registrant.

Terms and Conditions

- Registration fee includes access to business sessions and exhibitions, refreshments, delegate kit, entry to conference-related networking functions, three days conference lunches, and two days dinner, coffee/Tea during the conference provided at the designated areas, and access to Cultural Events.
- 2. Registration fee does not include hotel accommodation, airport pick/drop, and local transport; delegates are advised to make hotel reservations in advance to avoid last-minute rush.
- 3. Registration to the Spouses accompanying the delegates is mandatory. Registration of Spouses includes entry to Exhibition Hall, welcome Dinner on 3 March 2024 and Gala Dinner on 5 March 2024, access to Cultural Events and other social events during the conference, excluding the Business Sessions.
- 4. Registration of all foreign nationals should be made only through Overseas Registration link provided in the website.
- 5. All payments for the Overseas delegates are in US Dollars
- 6. Registration Fee once paid to ISC/AISEF will not be refunded for any reason.
- 7. While filling the application form, make sure you provide the proper details. Name of the delegate, email id, Company name and Phone numbers will not be changed once you finish the registration.
- 8. Delegate badges will be provided during the event at the registration counters. All delegates are requested to keep the Registration Badge all through the conference and exhibition as entry to sessions, lunches, dinners, etc. are controlled by the QR code on the registration badge.
